Annual review of reports for 2021.

We have received and reviewed the following monitoring reports for 2021;

- Form A1, S1, R1, WU1, E1 and PI1 received 28<sup>th</sup> Jan 2022.

At the same time the EMS was reviewed.

No ELVs were breached and no significant findings identified.

Comments;

Haz waste previously removed in significant qty in 2020 leading to less in 2021.

A1 – EP A1 was not monitored as this was out of action at the time, previously communicated.

S1 – pH is noted as a challenge that will be addressed via an improvement plan for pH correction and additional DAF capacity.

Emission point A11 – this is explained as venting to the odour plant and will need removing via Permit Variation. It appears to have been introduced at V006 variation application by mistake.

Water usage is raised but per tonne of product was reduced.

The EMS review identifies the trade effluent challenges and identifies further the business critical nature of investing in this area. It also highlights the energy savings, 5-7.7MWh, realised by utilising some of the heat recovery from the CHP.

Additional efficiencies include LED lighting and replacement of compressors.
