4. Details of our assessment

A routine site inspection was undertaken on Wednesday 16th March 2022. Natural Resources Wales officer, David Morgan, was met on site by Mark Swain, Technical Competent Manager for the site.

The previous inspection of the site was on 14th February 2019. There are no outstanding compliance issues. No non-compliances were recorded against the Environmental Permit during the inspection of 14th February 2019.

Operational Areas & Site Development

An inspection of the operational areas of the site was undertaken and the following observations were made:

- * General housekeeping on site is of a very high standard with no signs of leaks, spillages, accidents involving waste fluids/oils
- * New spill kits have been made available on site
- * All wastes oils were clearly labelled and segregated
- * All vehicles on storage racks appeared to be depolluted

Towards the rear of the site (upon entering through the main entrance) the site is undergoing development works to increase the operational area. The area that is under development is within the permit boundary for the site so can be utilised for on-site operations as long as permit conditions are complied with (infrastructure requirements etc.).



It is noted that Hopkins Builders is carrying out this work and it appears non-waste material (aggregates) are being brought on to site to complete this work. You must ensure this material, if waste, is accompanied by the correct documentation (Waste Transfer Notes) and is used with a suitable authorisation. If the material is non-waste, you must ensure it meets Quality Protocol standards. You can do this by enquiring with the producer of the material.

Environmental Permit & Management Systems

Following an inspection of the operational area of the site, we discussed the Environmental Permit and Management Systems.

Copies of the Environmental Permit, Environment Management System and Fire Prevention & Mitigation Plan were made available on site and staff have convenient access to copies of these documents as is required by the permit.

It was noted that the Technical Competency qualifications that Mark Swain has obtained are due to expire on 26/08/2022. Please ensure these qualifications are renewed ahead of the expiration date.

Summary

No non-compliances were recorded against the Environmental Permit. The operational areas of the site are well maintained.

Please ensure records duty of care checks are undertaken on material being used to redevelop site, and that any activities that take place in this new area comply with Environmental Permit conditions. Also, as the site is redeveloped, amendments will need to be made to the Environment Management System and Fire Prevention & Mitigation Plan.
