4. Details of our assessment

This report relates to the final site visit at Personnel Hygiene Services Ltd, Unit 49a Portmanmoor Road, Portmanmoor Industrial Estate, Cardiff CF24 5HB that took place on 17/03/22, the permit number: EPR-NP3999FD.

The Waste Regulation Officer Magda Leonowicz met with Raza Sardar at the site. The weather was sunny and dry. This was a pre-arranged final site inspection prior submitting a surrender application. The site was operational until December 2021 then the land was returned to the landlord.

Inspection:

The site has been taken over by new tenants and there is a warehouse now.

There were no wastes present within the permitted area at the time of the inspection. There was no machinery present within the permitted area. Site activities had clearly ceased.

No risk or evidence of an ongoing pollution to ground or water was identifiable at the time of the inspection.

Summary

No compliance breaches were identified during the inspection. In addition, the records of the historical site inspections do not show any compliance issues that could affect the condition of the land/groundwater such as leaks or spills of polluting substances. There were no records of any incidents that could be a risk of pollution to the land/groundwater. I can confirm that **the permit is suitable for a low risk surrender**.
