### 4. Details of our assessment

During a routine compliance assessment check we have carried out on 29/03/2022 it was noted that the EDM returns for EPR permit BB3390ZA Saron - A484 O.S. Maesgeler were missing from your 2020 EDM Annual Return.

The permit variation to add EDM conditions became effective on 10/07/2019 so, in accordance with permit condition 4.2.2, the annual EDM returns for this site should have been submitted in the 2020 return by the end of February 2021. Therefore a non-compliance occurred on 1 March 2021. We have used this non-compliance date at the top of the form to enable accurate annual reporting.

Actions – please carry out the actions specified above to comply with permit condition 4.2.2.

It is an offence under Regulation 38 (2) of the Environmental Permitting Regulations 2016 for a person to fail to comply with or to contravene an environmental permit condition.
