4. Details of our assessment

This was a routine, unannounced site inspection. Officers were accompanied by the Environment, Health and Safety Compliance Manager.

The operator had recently cut down trees / hedges around the perimeter of the landfill. Some of this wood was stored inside the MRF building. The operator explained that they were drying it out so it could be used as fuel in the Small Waste Incineration Plant (SWIP).

Outside of the MRF building, there was a metal container which the operator stated contained ash from the SWIP. This is discussed in CAR_NRW0039582.
