4. Details of our assessment

The Fugitive Emissions Review for 2021 was received on 25th March 2022.
The report is accepted.

There were no fugitive emissions from the site during 2021.

A significant potable water leak was identified and during the repair damage to underground drainage channels was also discovered. All the repairs have been completed and the roadway re-laid. Road surfaces elsewhere have been repaired and the fall improved in some areas to better direct surface water into the interceptor channels near the effluent treatment plant. The area around the waste metal skips has been re-laid to prevent surface water draining into the bund, reducing the need to dispose of the contaminated water as waste.

Hazardous waste is not stored outside.

More cameras were added to the CCTV system in 2021.
