NAG Recycling Site Visit, Crosskeys (EPR/EB3433RE) – 10/06/2019

Environment officers Craig Coleman & Martyn Davies attended the NAG Recycling facility in Crosskeys to meet with Grant Haines and discuss the removal of the waste from site.

(C3) Materials Acceptance: Permit Condition 1.1.1, Table 1.1 *Ongoing non-compliance not scored

This is an ongoing non-compliance and you are therefore not being scored on this occasion.

Action: See suspension notice currently in place.

During the site visit the progress of waste removal from the site in compliance with the Regulation 37 notice was assessed. The wood waste pile had been almost completely removed.

The mixed waste pile had also seen a reduction but was still over 6m in height. Significant work will need to be undertaken to reduce this pile as it remains a significant fire risk.

The aggregate pile remained in much the same condition as it had during the previous site inspection.

Additional Comments:

The primary purpose of the site visit was to meet with Grant Haines and to explain the Regulation 37 (EPR, 2016) and explain that no waste was allowed to come on to site. Mr Haines explained to me that they had removed a large amount of waste and that they were hoping to remove a large amount again in the coming weeks, but as there was no money left in the business the staff on site were working unpaid. Mr Haines said that the waste was being exported to GLJ Recycling. Mr Haines does not have any accreditation in waste management (WAMITAB).
