- Transfer station inspection to include waste types, storage areas and the screening operation. All activities were complaint.

- Compared to previous visits, waste quantities on site are greatly reduced, and the main bay was only 1/3 full.

- TCM update - John has now obtained an appropriate WAMITAB certificate. Lance Jones (Enviresource) is still available if cover needs to be brought in.

- Separately, the HHW site has now closed. Householders now use the new Potters facility just off the main roundabout at the bottom of hill – but it's not permitted to accept plasterboard, asbestos or tyres, so there have been reports of an increase in local flytipping.

- Proposed compost operation plans still ongoing.
