The purpose of the visit was to assess compliance of JLA Recycling Ltd with their Environmental Permit **EPR/NP3498FK**.

I was met on site by Mr John Adams, the Operator and Technically Competent Manager for the site. Mr Adams gave a brief overview of the operations on site, followed by a tour of the site.

At present the site is primarily a commercial waste transfer station. The Household Waste Recycling side of activities is no longer operational. Local residents are now required to use the new Potters facility in Cwmtwrch.

Waste Acceptance

On arriving at the site, lorries are directed over the weighbridge to the lower level, sunken bay. At present, the majority of waste entering the site is commercial, plastic waste. All waste is inspected on tipping into the bay and any rogue waste removed and disposed of in line with appropriate procedures.

Authorised waste is sorted and transferred to either recyclable storage or for acceptance into the adjoining landfill.

Environmental Permit and Environment Management Procedure

Following inspection of the site I asked to see copies of the Environmental Permit and Environment Management System (EMS). These were readily available.

Advice and Guidance

It was noted that the current Environment Management System (EMS) still includes the Household Waste Recycling activities. We would recommend that this document is amended to include the fact this activity is currently non-operational. It is important that the EMS is a live, working document which reflects the current operations on site.

Overall, the site looked to be fairly well organised and waste levels on site appeared low.
