B4 - Infrastructure - Containment of Stored Materials - CAT 4 - Permit Condition 4.6 states that ferrous and non ferrous metal shall be stored in areas with hard standing or impermeable pavement. Mixed scrap metals / material stored on unmade ground off the concrete pad.

C3 - Management - Materials Acceptance - CAT 4 - Permit Condition 1.2.1 states no wastes other than those which are categorised in Table 1.2 and specified in detail in Appendix A to these conditions shall be accepted at the site.

Large volumes of processed and un processed material namely; ferrous material removed from bottom ash EWC 19 01 02 from Viridor Trident site Cardiff was found stored on in site.

Please ensure that all material is stored on the concrete pad.

The storage and treatment of EWC 19 01 02 will require assessment and a permit variation. I will contact you to discuss this matter in detail.
