Part A. This is an ELV and waste metal treatment and storage permitted operation. It was being conducted inline with the Environmental Management Plan for the site.

Part C. The TCM for the site is Christina Lloyd who has a current WAMITAB certificate which expires on 14/03/2018.

Non Depolluted vehicles arrive at site and are stored on correct infrastructure before being depolluted in dedicated building. Depolluted vehicles are stored prior to baling.

Other metals were treated and stored correctly.

Tyres were stored in container alongside Depollution building and are collected on a regular basis

Fluids from depollution process are stored securely in the dedicated ELV depollution building.

All material acceptance, storage, handling and segregation was in accordance with permitted conditions.

Part F. There were no breaches concerning Amenity issues including, odour, noise, dust, fibres and particulates (Including oil and other material from vehicle depollution). There were no deposits on access roads.

The site was operating in line with permitted conditions and no breaches were identified.
