The purpose of this visit was to inspect the removal of the unpermitted wastes identified on site on 19 December 2017. The site was visited by Liz Park and Madeleine Starks.

At the time of the inspection it was observed that the unpermitted wastes were in the process of being removed from the area where they had been deposited towards the area by the gate. It was unclear as to whether they were being moved to be removed from site or to be transferred to Permit GB3937RF (SR2010 No.12). Please can you clarify upon receipt of this CAR. If the wastes were removed from the site, then you are required to provide copies of the waste transfer notes.

Restoration

A restoration and closure brief was requested by Friday 9 February 2018. This has not been received. As previously mentioned there has been limited progress towards restoration of the landfill which should have been completed in 2016.

It is therefore suggested that a meeting is arranged to discuss the current situation and the progress to full restoration. A separate letter will be sent regarding the meeting.

The following non-compliance has been identified.

G4 - Reporting and notifications to Natural Resources Wales - Permit Condition K1.2 - CCS C3

You were previously scored a CCS C4 breach for failing to submit waste returns for 2016 and Q1, Q2, and Q3 - 2017. Q4 - 2017 is now also due for submission.

No waste returns have been received. Therefore you have now been scored a CCS C3 non-compliance.

Please note that even if no waste had been received you are still required to submit a waste return.
