Alex Bowder attended site on Tuesday 11th October 2016 at 10:30 and met with Malcolm Smith to conduct a site inspection of the Penmaen HWRC. The weather was mild and dry.

Malcolm completed his continuing competence of the WAMITAB qualification on 03/03/16 which will expire in 2018.

Plasterboard, tyres and asbestos are not accepted at this site. As the site is closed on Monday, it was mentioned that the public have been known to tip their waste outside the front gate when locked. A sign has been placed and chained to the front gate stating the illegality of any tipping to try and prevent such activities.

When the compacting of the skips takes place, for health and safety purposes the site uses the orange barriers to stop the public from driving into yard when the vehicles are in operation. This will need including in the EMS so that operations are recorded.

No unauthorized waste seen on site. Good general housekeeping with no litter seen.
