At 11:50 on 01st May 2018 your site was inspected as part of the routine assessments for compliance, your new regulatory officer, Richard Palmer, was in attendance along with fellow officer Ian James. Thank You for taking the time to demonstrate your activities on site. Your operations consist of a Transfer Station and a Household Waste Recycling Centre for public use in the Five Lanes (Caerwent) area.

C1 - General management: Staff Competency/training

Rhys Lloyd and Pete Somers (TCM accredited) at required level.

C2 - General Management: Management system and operating procedures

All waste returns are up to date and in compliance.

D1 - Site Security - Action Only

Further to discussions with Rhys Lloyd on site Viridor are aware of Site Security issues and attempting to rectify them prior to NRW site visit. As was discussed with the site supervisor at the time of the visit there was still evidence of windblown litter outside of the perimeter fence - an increase of litter picks by site staff and increase of area protected by green netting were discussed as possible actions to reduce windblown litter escaping from the permitted area. Also the fixing of damaged fencing was discussed to prevent unwanted access by members of the public looking to take waste goods from the site.

Part 1 - Continue green netting further around site and potentially heighten the fenced area directly behind where the lorries are being loaded.

Part 2 - Fix the damaged area of fencing that was highlighted to the attending officers at the time of the visit to prevent further unwanted access. Installation of new CCTV cameras was also discussed and would also help to prevent illegal access.
