4. Details of our assessment

During a routine compliance assessment check we have carried out on 01/04/2022 it was noted that the EDM returns for EPR permit AA0025601 CSO ADJ SHAFTESBURY PS

NEWPORT were missing from your 2020 EDM Annual Return.

The permit variation to add EDM conditions became effective on 06/02/2020 so, in accordance with permit condition 4.2.2, the annual EDM returns for this site should have been submitted in the 2020 return by the end of February 2021. Therefore a non-compliance occurred on 1 March 2021. We have used this non-compliance date at the top of the form to enable accurate annual reporting.

Actions – please carry out the actions specified above to comply with permit condition 4.2.2

It is an offence under Regulation 38 (2) of the Environmental Permitting Regulations 2016 for a person to fail to comply with or to contravene an environmental permit condition.
