Summary

This inspection was conducted as part of the regular compliance inspections which are required throughout the year. Thank you for taking the time to show your regulatory officer around site.

A basic site inspection was conducted to determine whether you are compliance with the storage conditions specified by your permit. You have previously been scored breaches against the permit for storing waste in skips outside of the concrete area which drains to an interceptor.

On this occasion, it was very positive to see that the site appeared clean, organised and well managed and all waste was stored in line with permit condition 4.6.1. Thank you for your cooperation by achieving compliance as requested previously.



Other Comments

We have been informed that you have been operating outside of your permitted operating hours, which are: 8:00am to 17:00pm Monday to Friday and 9:00am to 14:00pm on Saturdays. Sundays and Bank/Public Holidays are excluded. Please ensure you consider these restrictions before operating heavy plant and other vehicles outside of the permitted operating hours.

While you are currently compliant with your storage conditions, **please be aware of the fire risk your site poses.** The longer material is left in situ without being processed, the higher the risk of fires. The site is also at risk of arson and you should consider the implications of a fire at the site. Please aim to increase the rate at which material is deposited and exported from your facility and prioritise the export of older or biodegradable material. Your fire risk assessments and incident/accident management plans will be assessed during the next compliance assessment.
