Environment officers Laoni Tye and Nessa Dearle visited site on the 5th April 2017. Suzanne Trembath was on site at the time of the visit along with other staff who were operating machinery and sorting the waste. The visit was in response to a complaint that was raised with burning on site which was the main focus of the visit. A more detailed visit is due to be conducted soon.

Breaches recorded

A1 – Specified by permit. Category 3 Breach.

Permit condition 4.3.1 States that no waste shall be burned on the site.

Whilst on site we saw that there were two bins that had fire burnt wood waste in them. We were advised that bits of wood are sometimes burnt in order to keep warm in the mornings and there was evidence that this was a repeat occurrence. As discussed on site, you are not permitted to burn any waste on site even if this material is wood, as seen on site by officers. Some of the wood looked to be treated wood and has likely come onto site as waste wood. Burning waste wood in this matter is not only a breach of this permit condition but would also be considered a fire risk, which could potentially lead to a significant breach if a fire on site was to occur on site. The risks were understood during the visit.

Action: You must not burn on site.

We are due to conduct an additional visit soon where we will look at the site in more detail including checks on TCM, EMS, storage and infrastructure.
