As advised on site the purpose of the visit at this time was to introduce myself and gain a better understanding of the processes on site. A full compliance inspection of the site will be conducted over the following months.

Susanne Trembath has now completed her WAMITAB and is the TCM for the site. Thank you for letting us know this, we have documented the certificate and we will update our records accordingly.

The next inspection is likely to include an audit on the sites compliance with Regulation 13(1) of the Waste Regulations (England and Wales) 2011 as amended. As discussed with previous officers and included on a CAR form dated 04/08/2015, "Since 1st January 2015 waste collection operators including private companies, social enterprises and local authorities are required by to law to provide their customers with separate collections for paper, metal, plastic and glass where this is necessary to improve the quality of recycled material by reducing contamination at the point when the recyclable material is collected.

Please take a look at the CAR form dated 04/08/2015 for further information and guidance. We will be assessing any compliance with this during our next visit and offering any advice and guidance as necessary to assist in complying with this regulation.
