Cwm Rhondda Skip Hire Inspection

This inspection was conducted to complete a site handover from Will Powell to your new Regulatory Officer Adam Ward. This was also an opportunity to conduct one of the regular compliance assessments required throughout the year.

It was noted that waste stockpiles have increased on site as one of your customers has stopped taking waste. This has caused a backlog of material on site and has therefore exacerbated the capacity issue. As a result, you have been scored the following breach;

Compliance

C4) Management – Storage, Handling, Labelling and Segregation

Permit Condition 4.6.1 – clearly states that solid waste which are likely to produce polluting or contaminating run-off should be stored on impermeable surface and sealed drainage. Further, degradable HCI wastes should also be stored in sealed containers, in covered shelters or in bays.

You are currently storing a number of skips containing mixed waste outside of the impermeable surface. **You have therefore been scored a Category 3 breach of Condition 4.6.1.**

Action

We appreciate the cost involved with extending the impermeable surface, but this is certainly something you should consider implementing medium to long term. In the short term, you are advised to update your management system/working plan to demonstrate how you intend to deal with the storage capacity issue to avoid incurring further breaches in future.

Please provide your regulating officer with the updated written procedures within 30 days of receiving this CAR form.
