Environment officers Nessa Dearle and Hayley Barrett completed a site visit to assess compliance with your waste permit on the 13th of June 2018. We were shown around site by the sites technically competent manager, Susanne Trembath and Andrew Trembath.

Thank you for taking the time to show me around site. The site appeared well managed at the time of the inspection and no breaches were recorded on site. Following my last visit, I was happy to see that the site machinery had been repaired and that waste management had improved.

Notes

On site problems were raised relating to your permit conditions and the levels of waste on site. Your environmental management system outlines that waste in the storing area must not exceed 4 metres. However, the management system also outlines that the walls surrounding the lower yard are built to a height of 3.2 metres. In line with your permit the waste levels should be below the level of surrounding walls/bays. As specific bays do not exist on site, it will be necessary for me to assess the levels of waste that will adequately eliminate risks of waste escaping from site. I will raise this issue with our permitting team for advice and discuss the outcome at my next site inspection.

During the visit, we also discussed the arrival of non-permitted wastes on site. I was happy to see that measures have been put in place to prevent non-permitted waste types arriving on site. If non-permitted sites are accidentally accepted on site, ensure that these wastes are kept separate to permitted waste in a quarantine area.
