**Modification of Waste Management Licence number: Brec/03/93 (30106)**  
**Return of Financial Provision**

Please find enclosed Notice of Modification with regard to the above waste management licence. This modification has been undertaken under the Agency's own initiative to remove the condition that required your financial provision agreement to be maintained.

The Agency has recently changed its policy with regard to financial provision for non-landfill waste management licensing. Applicants and licence holders can now satisfy the Agency on the financial provision test by demonstrating financial health. This can be done through credit checks or evidence of sufficient funds. The arrangements you previously made with the Agency are no longer necessary and financial provision will not be reassessed unless you apply to modify the licence and increase the licence obligations. Please read on to see how the financial provision agreements will be returned.

**Bond:** Bonds will be returned to the bondsmen (normally banks) before the end December 2003 thereby cancelling them. The legal agreement will be returned to the licence holder by April 2004.

**Cash Deposit:** The deed of trust and cash payment together with interest earned and tax certificates will be returned to the licence holder by April 2004.

**Escrow:** You will receive a letter of authority signed by our authorised signatory with a space for you to sign, confirming to the bank that the account should be closed and the money paid out to the licence holder.

**Insurance:** The policy will be returned to the insurer with a covering letter requesting that the policy be cancelled forthwith. The bond will be returned to the bondsman and the legal agreement will be returned to the licence holder.

**Parent Company Guarantee:** The guarantee will be returned to the guarantor.

**Local Authority Agreements:** The agreement will be returned to the Local Authority.



The return of all the financial agreements and cash deposits is being handled by a central team. Bonds are to be returned to the bondsmen and banks by 1<sup>st</sup> January 2004, so please contact your bank if you need to find out more. All other agreements will be returned by 1<sup>st</sup> April 2004. If you have any enquiries please address them to:

This notice of appeal should be accompanied by the following information:

- A statement of the grounds of appeal;
- A copy of any application to modify the licence
- A copy of the licence;
- A copy of any correspondence relevant to the appeal;
- A copy of any other document relevant to the appeal including, in particular, any relevant consent, determination, notice, planning permission, established use certificate or certificate of lawful use or development and
- A statement indicating whether you wish the appeal to be in the form of a hearing or on the basis of written representations.

You are also required to serve a copy of your notice of appeal, together with copies of any the above documents that have accompanied your notice of appeal, on the Environment Agency (at the address overleaf). You should appeal within 6 months of the date that this notice takes effect but the Secretary of State may allow notice of appeal to be given after the expiry of this time period.

### **Decision Document and Compliance Plan**

#### **1. Introduction**

Area	South East
Region	Wales

**Waste Management Licences for non landfill sites need to be modified to delete a condition that required financial provision to be made and maintained.**

In July 2003 the Agency issued a new financial provision policy whereby applicants for non-landfill licences can now satisfy the Agency that they are fit and proper if they are in a position to make financial provision. Normally this will be by financial health check or proof of means (e.g. funds in bank).

Licences for sites other than landfills with a financial provision agreement secured with the Agency under the previous policy are available on request. It is no longer necessary for licence holders to maintain these financial provision agreements with the Agency. In order to effect their cancellation the conditions referring to financial provision now require to be deleted.

Once the licences are modified the agreements will be returned together with any bonds and cash held by the Agency on their behalf. This will be undertaken by the Financial Provision Project Team (contact Charlotte Danvers, Waste Permitting and Compliance Process for further information).

#### **2. Consultation & Other Representations**

The Health and Safety Executive and all Local Planning Authorities have been consulted. Appendix 1 details the comments received those consultees that responded.

#### **3. Licence Conditions**


All the modifications are by the Agency's own initiative to delete a condition that required financial provision to be made and/or maintained. A standard condition has been developed that does not need the licence condition number or the exact wording to be referred to, as follows:

***Whereas the licence had a condition requiring financial provision to be made and/or maintained this condition shall now be deleted.***

**4. Fit and Proper Status** Not applicable for this modification under the Agency's own initiative. Licence holders will not be reassessed for financial provision under the new policy unless they apply for a new licence, transfer or modify to increase the obligations.

## 6 Compliance Plan

The Inspecting Officers for the licences modified under this decision document should note the following:

- 6.1 The Modification removes the requirement for the licence holder to hold and maintain the financial provision agreement made under previous Agency policy.
- 6.2 The Licence holder has not been reassessed for financial provision. They will not be required to demonstrate their financial health to meet the obligations of the licence until and unless they apply to modify the licence and increase the obligations.
- 6.3 The Financial Provision Project Team will organise the cancellation of the legal agreements centrally, as follows:
- Bonds will be returned to the bondsmen (usually banks) by end December 2003. A licence holder should contact their bondsman to check it has been cancelled.
  - Cash deposited with the Agency will be returned together with interest earned and the relevant tax certificates by end March 2004.
  - All other agreements will be dealt with by end March 2004.
- 6.4 If in **April 2004** a licence holder has not had the agreement cancelled they should be advised to contact the Financial Provision Project directly.
