Environment Officers Liz Park and Madeleine Starks conducted a site inspection on 21/12/17, focusing upon Permitted Wastes (section 1.2. of the permit) and Engineering Site Containment and Drainage Systems (section 2.1 of the permit). The weather conditions were cool with occasional showers. Unfortunately, we were unable to conduct a full site inspection as intended as there was no one available to meet us, however we were able to access the site via the track to conduct a brief, visual inspection.

Advice and Guidance

While on site we noted that there were several skips of waste stored outside the permitted area. We understand that some of the waste stored on site does not belong to Dyfi Skips, however all skips and their contained waste associated with Dyfi Skips should be stored upon the impermeable concrete surface within the permitted area.

Additionally, we have received a report of the burning of waste at your site. We are aware that other private individuals may also use a section of the yard beyond the permitted site, so we understand that this may not have been occurring on your site specifically. However, in line with NRW procedure, we would like to remind you that the burning of waste on site is considered an offence under the Environmental Permitting Regulations 2016. No fires are allowed on site.

We hope to discuss these matters with you and intend to re-visit the site to conduct a full site inspection during the new year. To ensure you are available, we will be in contact in due course to arrange a convenient time for this appointment.
