Your operation consists of a 'Waste Transfer Station' in the Pontypool area.

Permit Condition 6.2 Records of waste movements

6.2.2 A summary record of waste types and quantities accepted and removed from the site shall be made available for each quarter of the financial and shall be submitted to the Agency within one month of the end of that quarter. The summary record shall be in the format detailed in appendix B or otherwise subsequently agreed with the agency in writing.

Observations;

1. This was the first inspection since the exit from the business of previous MD Mr Ian Lynass. Mrs Christina Lloyd (Compliance Manager) supervised the visit.
2. During the Site Inspection it was noted that some wood waste has been chipped and stored within the boundary limits of the Metal Recycling Site (Permit EPR-UP3495FT). This permit wasn't inspected at this time as there will be a scheduled inspection in March but it isn't permitted to hold this material. I understand that this was a temporary measure whilst awaiting removal, please ensure this is completed by 15th February 2018.
3. Materials within the Transfer Station section of the site were well segregated.
