Tony Bruten attended site with Ian James and was met by Ian Lynass and Christina Lloyd. The inspection was for both permits, there is a separate CAR re permit UP3495FT. There are some overlaps as the perimeter of the yard covers both sites. This has been covered as D1 of this inspection and although there has been development on the site there is no issue with the current site security.

The amount of waste in this area of the permit has reduced considerably under the new management with a variation in the method of processing at this time.

Mixed waste is still brought to site and is being sorted by hand before onward distribution. Volumes of waste are well within permitted levels and are stored and treated on impermeable surfaces.

There were no breaches of permit identified at time of inspection.
