G4 – Monitoring and records, maintenance and reporting: Reporting and notification

Permit Condition 6.2– ‘Records of Waste Movements’

All waste returns are up to date and in compliance.

It was noted that there is a proposal to open 5 days a week from 1st September, these would be Sat, Sun (10am to 4pm) and Mon, Tue, Wed (9am to 5pm).

A tour of the site showed infrastructure in good order with no litter, loose debris or smells apparent. The conditions were sunny and warm.
