4. Details of our assessment

This was an unannounced, routine site visit. The weather was dry and it had been for some time.

General observations:

During the visit the NRW officer was accompanied by Scott Appleyard. The site was generally clean and well organised with good segregation of waste types. The hardstanding and treatment areas were in good condition and good waste storage practices were observed.

Depollution of ELV's:

Several of the ELV's on the hardstanding area were inspected and were found to be depolluted to a good standard. No fluids were observed and no signs of spillages or contamination on the ground.

Technical competence:

Scott Appleyard is the current TCM for the site and holds the appropriate WAMITAB certification. Evidence of continued competence was not seen and it is believed it may have expired. Scot Appleyard will look into this and submit evidence of continued competence.

ACTION: Scot Appleyard to submit evidence of continued competence to NRW.

No noncompliances were observed during the visit.
