4. Details of our assessment

This Compliance Assessment Report (CAR) has been raised due to the completion of an Operator Monitoring Assessment (OMA) to Air & Water.

The OMA reports are attached to the accompanying email.

The final OMA to air score was 100% and no CCS scores have been generated.

The final OMA to water score was 89% and has attracted a CCS score as outlined below.

OMA 1C and 2C highlighted that there was a minor improvement required to the management system in the 2017 OMA assessment. This recent OMA identifies that the action has not been carried out despite PR-25815 being reviewed and re-dated to a 2022 version. This represents a failure of EMS procedures.

Score: (C2) Management system and operating procedures. Permit Condition 1.1.1(a). CCS 4.

Action: The tables for emissions to water in Environmental Monitoring Management Procedure PR-25815 should be updated to reflect the new wording of the permit variation issued in 2016. Schedule 3(b), Table S3.2 Emissions from 30/09/2018 is the currently permitted table of emissions.
