4. Details of our assessment

Responses to the improvement conditions (IC) were received by the due date of 17th February 2022. The documents received confirm that Tradebe will be compliant with the BRef and BAT conclusions detailed in IC14 and IC15 by 17th August 2022.

Improvement Conditions IC14 and IC15 have been completed and can therefore be closed.

IC16 remains open because of the difficulties Tradebe have experienced in using the H1 Assessment Tool. No decision can be taken regarding the monitoring required in the permit until the H1 assessment has been completed. Tradebe will not be issued with a non-compliance as the delay is beyond their control, but they should try to complete the assessment as soon as possible.
