4. Details of our assessment

Response to CAR_NRW0039465

The site has sent details of the planned stack monitoring and permit variation submission. The monitoring was planned to be undertaken on the 1st April and the permit variation is planned to be submitted at the end of April.

The site has submitted an overview of the planned improvements for spill response and training.

The sites spillage teams have had further training and the site is ensuring that all shifts have sufficient cover to address spillages across the entire site.

The site has located the drain covers that were not found during the last inspection and have updated the spillage kits. The site is in the process of creating shadow boards to show the contents of the spillage kits. The site is creating a checklist that will be completed on a weekly basis to ensure that spill kits are always ready to deal with any spillages.

These are significant improvements to the sites ability to deal with spillages.

The site has installed a fire rated bunded store with 32 IBC capacity. The store is split into 4 compartments to ensure chemicals can be stored to reduce any domino effects if an incident were to occur. This is a significant improvement of the storage of the IBCs at unit D. The site has not sent over further details of the IBC contents for unit D as requested in the CAR form.
