4. Details of our assessment

Celtic Chemicals Ltd (CCL) is a privately owned company who carry out chemical dissolution and packaging;

powders blending and repackaging; and storage and on-sale of chemicals.

The permit was issued in 2007 as a 'low impact installation' (LII) and it is a requirement that CCL provide an annual report showing evidence that they continue to comply with the LII criteria by the 31st of January annually.

CCL submitted the 2021 annual report on the 3rd February 2022. The late submission has resulted in a CCS score of 4. NRW would expect future annual reports to be submitted by the 31st January to ensure compliance with the permit.

Following assessment of the annual report, the subsequent observations were noted:

- Implementation of ISO14001 remains a potential improvement point. This has been a consideration since the permits issue in 2007.
- Issues surrounding the installation of the wastewater treatment plant continue, with the inability of the contractor resulting in CCL taking legal action to reach a resolution.
- All potentially polluting liquids are subject to primary and secondary containment. The secondary containments are periodically checked for integrity/suitability.

Other parameters described within the annual report confirms that CCL continue to comply with the specified criteria and will therefore remain a Low Impact Installation.

A site visit has been arranged for the 3rd May 2022 providing an opportunity for a site handover between NRW officers and to discuss the ongoing wastewater treatment plant issues.
