NRW Staff took a routine sample of your permitted water discharge on 21/01/2015. The results came through last week and showed that this water discharge had exceeded the limits of 100mg/l for suspended solids and were at levels of 252mg/l.

This is a significant permit breach and has been categorised as 2. On this occasion a written warning has been issued, but if breaches of this nature are observed in the future our enforcement response may increase.

Please investigate the cause of this breach and forward information regarding the likely cause of the breach and any remedial actions required to prevent further breaches.

It's possible that bad weather caused this breach, If this is the case, to prevent further breaches it may be that some earth works are required to improve the lagoon system serving the quarry.
