Any non-compliance we have identified and recorded on this form is an offence. It can result in criminal prosecution and/or suspension or revocation of your permit.

4. Details of our assessment

On arrival NRW officer met David John the office Manger. Mr John contacted our usual site contact Chris Morgan (company Director) by telephone and explained we were there. Mr Morgan was happy for David John to show the officer around the site.

General Observations:

General housekeeping on site appeared to be of a good standard. All vehicles stored on site

were free from leaks of oil and other liquids and there were no signs of spillages on site.

There was however some slight overspill from the area where oil is being poured into the waste oil drums. This is not a breach as the activity takes place (as detailed in permit) in the sealed drainage area but the process could be improved by moving the waste oil drums back further onto the pad.

ELV Depollution:

It was not possible to check the depollution process as no ELV's were being processed at time of the visit. Very few ELV's had been depolluted since our last visit. Most vehicles leave site as ELV for depollution at other sites.

Waste Storage:

At the time of the visit there was only a very small amount of end-of-life vehicles (classed as waste) on site. Vehicles that were end-of-life and considered to be waste were stored on the

impermeable pads with a sealed drainage system.

There were batteries on a pallet adjacent to the doors to the garage. Table 5.4 of your permit describes how such wastes should be stored. Batteries must be stored in containers with an impermeable acid resistance base and a lid to prevent the ingress of water. **This is a breach of your permit and has been recorded as a Category 3 breach.**

Drainage:

The drains serving the pads were visually inspected and were clear from any blockages. Surface water run-off appeared to be flowing freely. The discharge point on the Colebrook watercourse was free from any visual oils/greases.
