4. Details of our assessment

This was a routine site inspection carried out by Waste Regulation Officers Amy Henderson and Boguslaw Pierzchala. The weather at the time of the inspection was dry with sunny spells.

On arrival at site, Officers signed in at the reception cabin. The visit was carried out unaccompanied. The site was operational at the time of the inspection with members of the public arriving to deposit their waste.

The site appeared in good order and well maintained. There were no visible signs of any issues with litter. Waste was kept segregated into different fractions, and there were clear signs enabling members of the public to determine the correct area to place items. Staff were also on-hand to assist with any queries.

Items such as batteries and florescent tubes were seen to be kept in sealed/cover containers. TVs/monitors were also kept in a separate weatherproof container.

Waste oils were seen to be stored in a bunded container.

Some large electrical items were located at the far end of the site, near to the car-parking area. On discussion with staff we were informed these were items that needed degassing and were awaiting collection from a specialist company.

Following the visit, a copy of the sites most recent EMS was requested. This has not yet been received. This has therefore been listed as an action to provide this by 29th April 2022.

There were no breaches identified as a result of this site visit.
