This was a routine site inspection. The Head of EHSQ accompanied NRW staff during the visit which included observations of manufacturing operations and air emission points.

No issues were identified during the inspection.

No odours were detected on site or during an offsite odour assessment completed immediately afterwards. The odour assessment included the following areas: Vauxhall Industrial Estate, Heol Estate, Bangor Road and New Hall Road.
