Dinas (Porth) CA Site (AMGEN) – 23/05/2018

Environment officer Craig Coleman conducted a visit to the Dinas (Porth) Civic Amenity site 23/05/2018 and met with Ceri Evans and Lee Faulkes to discuss the expansion of the current location. Whilst on site an inspection of the facilities was conducted with Julian Davies the site manager. Please thank Mr Davies for taking the time to show me around site and to walk me through the waste streams that are processed at Dinas.

Litter

The site was very clear with minimal debris on the ground, netting had been installed along the perimeter fencing to stop any potential wind blow litter from escaping the compound.

Security

Site security was very good, the compound was surrounded by 8ft fencing which was bolstered by an electric fence.

Drainage

There is an impermeable surface on site to prevent any spillage from entering ground water, there had been an issue in the past with water pooling as the South East corner of the site, but a drain had been installed to prevent this. Site drainage was funnelled in to an interceptor which was maintained biannually.

Waste Returns

We thank you for submitting your waste return and note that you received 1481 tonnes of waste last year.

Other Comments

Waste types were well separated and had good signage to aid members of the public as to which container their waste should be disposed in. Spill kits are maintained on site to be used in the event of any spills. The key purpose for the site visit was to discuss the extension of the site, as AMGEN have acquired the former dog pound site directly adjacent to the East of the current facility. You have informed NRW of your intention to expand your current operations in to this site and that this will potentially see an increase to the tonnage of waste that is processed on site.
