Environment Officer Craig Coleman completed an audit on the ELV process at Grove Farm Autos on 10/04/2018 to assess the management and compliance with The End-of Life Vehicles Directive 2000/53/EC. This assessment included ensuring minimum infrastructure requirements to prevent and minimise pollution at the site, the storing and treating ELVs and the depollution and dismantling process to promote recycling and recovery. There were no breaches recorded.

The audit was undertaken on a Silver Vauxhall Corsa, registration CV57 XMH in the depollution bay of the site; with the depollution process being completed by Mr Gareth Lerwyn. The technical competent manger was Mr Mark Owen. Mr Lerwyn completed the process in accordance with the ELV regulations, with minimal deviation. Airbags were not deployed at these are maintained in situ for potential resale. No parts of the vehicle contained mercury and the oil filter was crushed on site, with the waste oil being deposited in to waste oil storage bund. The catalytic convertor was not removed at the time of depollution but would be later in the day. Catalytic convertors for the site as sold on to MGB Midland.

The fluid containment on side was all individualised between the different pollutants that were extracted from the vehicles; and the oil containers were double bunded. The surface of the workshop was comprised of impermeable concrete and spill kits were present on within the depollution bay.
