Officer Alice Sims attended a site visit at Bill Way Ltd, Tremorfa Industrial Estate. On site, director and site manager, Paul Way, provided a tour of the site and described how each element of a vehicle depollution is performed.

He first presented the areas in which the batteries and car fluids were kept after depollution. Each were stored neatly in appropriate containers, placed within a bunded area. My Way then explained and presented the drainage system that serves the depollution bay and the bunded areas, which all flowed into an interceptor.

Mr Way informed Officer Sims that he does not process any oil filters or catalytic converters on site, instead sending the oil filters to Bayliss metals and the catalytic converters to JWB Recycling.

The tyres and other removed vehicle parts were stored separately and neatly.

My Way then presented the site plan on paper to validate what he had shown Officer Sims during the site inspection. Overall, the site appeared to be operating depollution of vehicles in the appropriate manner, employing all of the proper practices on the correct infrastructure.
