I had requested that the Fire and Rescue Service (FRS) carried out a fire safety inspection. Myself, Chris Ferris and Geraint Parry from the FRS and Richard Bradley were all present.

The FRS Officers made several recommendations which they said they would put in a written report. The report would be sent to Richard Bradley and Neil Griffiths of Natural Resources Wales.

The amount of waste on site had been reduced. Notably, there was very little green waste or wood waste on site. Bays were now visible where the green waste and wood waste had been stored previously. The large amount of very old waste in the Southern end of the shed was still on site.

After the FRS Officers left site Richard Bradley agreed and signed a site improvement plan. For this reason non-compliance scores have been suspended as described in the site improvement plan. All the actions in the site improvement plan need to be carried out by September 30th 2015.
