The purpose of this inspection was to check if any waste had been brought back to the site following a fire on Friday 7th August, and also to see if waste outside the building had been taken off site yet.

Weather - dry and mild

No one was on site at the time of the inspection and the entrance gate and the shed were locked. We climbed over the gate, walked around the area outside the shed. I took some photographs of the waste that was being stored outside the shed. This waste had been moved from inside the building by the Fire and Rescue Service while dealing with the fire. It did not appear as if any more waste had been brought back to the site since the fire occurred.

The waste cannot remain outside the building and needs to be taken off site. The waste contains asbestos roofing materials so will need to be disposed of as hazardous waste. I understand that Richard Bradley was in discussion with his landlord to find out if insurance may pay for the removal of the waste from site.

Please can you telephone me on 28.09.15 to give me an update on when the waste will be taken off site.
