Gareth Danter-Hill attended site and there was no one on site at all to accompany the inspection. The weather was dry and sunny.

No issues were identified throughout the visit.

The site has a large amount of waste on site that has been here for a prolonged period of time, however the total volume remains lower than it has been previously despite a small increase in material on site. There is a pile of the waste (to the right of the site), that has been in place for well in excess of 3 years. This stockpile of waste will need to be removed as this time scale has landfill directive implications.

A skip was seen on site to contain wastes that have been hand picked out of the incoming waste.

All the waste on site is within the boundary.
