4. Details of our assessment

On Friday the 18th of March 2022 waste regulation officers, Boguslawa Pierzchala and Amy Henderson, visited the site. The weather conditions on the day of inspection were clear and dry.

Officers arrived along with George Newman and Thomas Bellis, assistant operation managers, who had met the officers earlier in the day at another site.

Mr Newman requested we sign in.

The site diary was inspected. Records in the diary gave details of who was on site, what type of waste was removed and when, and details of any accidents. It was noted that TCM's attendance was not recorded in the diary.

Action: Please ensure TCMs attendance is recorded in the site's diary. For **immediate** action.

The site is protected with several security cameras located around the site, security fences and gated entrance that is locked in the evenings.

The site was operating, accepting waste from the public with several site attendants working.

Officers witnessed the "meet and greet" procedure. Members of the public are asked what waste they would like to dispose of. This procedure minimises unauthorised disposals but also has other advantages such as minimising some pollution risks, such as oil spillage, as some members of the public might find it difficult to decant oil into the tank. By implementing the "meet and greet" procedure the site operative can offer assistance.

The site is well maintained and signed to assist the correct disposal of waste.

Recycle skips and containers were well maintained with no clear visible damage and that they were clearly indicated to what materials could be disposed in them. The walkways were also clear of any materials and no hazards were noted. The lower section of the site (no access to the public) was clear with easy access to all containers and skips.

The site does not accept gases in pressurised containers containing dangerous substances (EWC code 160504). There were a few such containers on site having been left there by members of the public.

These items were stored securely in a locked cage.

There is a re-use shop that operates from the recycling centre. It stocks a selection of electricals, toys, furniture and books with proceeds made at the shop benefit Nightingale House Hospice.
