4. Details of our assessment

This was an unannounced routine site inspection carried out at the Thorncliffe Ewloe site, EPR-BP3797SZ. The inspection was carried out by Waste Regulation Officer Amy Henderson. The weather at the time of the visit was mainly dry with intermittent sunny spells.

Site Manager, Dan Harper was not onsite at the time of the visit. The visit was partly carried out unaccompanied and partly accompanied by site Health and Safety Officer Becky.

The site was operational at the time of the visit, mainly with skip wagons arriving to deposit collected skips. The sorting of this waste was taking place. The treatment of inert waste was also taking place. Although the site was busy, it appeared tidy and in good order.

No issues were identified with litter, odour or pests.

Waste onsite was seen to be stored in compliance with the permit conditions. Quantities of waste onsite at the time of the inspection were deemed to be within limits and were being stored in compliance with the sites Fire Prevention and Mitigation Plan.

During the inspection a site operative was dampening down the site to minimise any dust, as per the sites EMS for dust management.

Generally the surface of the site was in good condition however an area of the impermeable surface was found to have deteriorated. This was not located within an area where waste was being stored, however run-off from the top area of the site could flow in this direction and risk contamination of the ground underneath. It has therefore been listed as an action to monitor this area for further deterioration and carry out any necessary repairs to ensure continued compliance with the drainage conditions of the permit. Since the last visit to the site, further resurfacing work has taken place within the area added to the site boundary, during the most recent permit variation.
