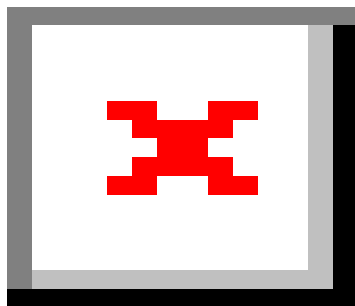

Alex Bowder attended site on Tuesday 11th October 2016 at 12:30 and met with Malcolm Smith to conduct a site inspection of Trehir HWRC. The weather was mild and dry.

Malcolm completed his continuing competence of the WAMITAB qualification on 03/03/16 which will expire in 2018.

The Trehir HWRC borders the closed landfill site. It is claimed that this site is the busiest out of the HWRC facilities due to the location.

The site has experienced problems with the track machine ripping up floor next to the skip bays due to general wear and tear. Fresh tarmac has been laid down, however it seems that this won't last long with heavy machinery travelling over the surface. This will need to be monitored and replaced when necessary.

The channels put in around three weeks ago and seem to be working. The drainage for the HWRC area of the yard leads to the hill through interceptor which then meets up with leachate from closed landfill and exits to foul sewer drain.

The yard operations clean between the skips every day and was looking fairly tidy. Rubble and hardcore in skip one goes to Bryn Quarry.

The road that leads to the site is private - people continue to tip waste when the site is closed and gates locked. A security camera was added to help prevent such activities.

Waste Returns

The business has been using the correct EWC codes on the return spreadsheets and have been submitted diligently for this year's quarters so far, please continue this habit.
