Laoni Tye and Alex Bowder met with Malcolm Smith and Scott Jones on 24th June 2015 to conduct a site handover to Alex. Thank you to Malcolm and Scott for showing us around and explaining the operating procedures during the visit. All areas of the site were inspected, weather was warm and dry.

We were informed that Peter has recently left the business and so Scott will be taking over responsibilities.

We were satisfied that the site is accepting the correct waste types, we did not see any unauthorised waste accepted on site. Staff appear to be following the correct waste acceptance procedures. Only a certain number of the Caerphilly amenity sites accept asbestos and Japanese knotweed and so waste is turned away if not authorised.

Skip bays are adequately separated and with no leaks or containment issues. All waste unloaded and stored in the designated areas in accordance with the working plan.

There were spill kits located on sites that the staff were aware of. There are procedures for recording and reporting all incidents on site.

Health and Safety issues adhered to.


There is 24 hour CCTV monitoring and any break ins are reported to the police and recorded.

F3 - Amenity - Action

Dust - the drainage channels were clogged with dust which was probably from the tyre tracks on the machinery. This needs to be cleared in order for the drainage system to operate properly.

All other areas of the yard were within the permit conditions.
