### Introductory note

#### This introductory note does not form a part of the notice

The following notice gives notice of the variation of an environmental permit.

This is an operator initiated variation of a tier 3 landfill permit to:

- incorporate the closure report, capping design and specification report, restoration soil pH review and waste recovery plan approved by Natural Resources Wales; and
- include a condition requiring the operator to maintain a closure and aftercare management plan.

This variation also updates (as a regulator initiated variation) the permit holder name to Tata Steel UK Limited, add conditions allowing for the reports to be incorporated, and to prohibit waste being accepted for disposal.

This permit variation reflects the status of the site as being in definite closure.

The schedules specify the changes made to the original permit.

The status log of a permit sets out the permitting history, including any changes to the permit reference number.

1. No waste shall be accepted for disposal within the facility.

### Schedule 3 – conditions to be added

The following conditions are added as a result of the application made by the operator

24. The operator shall maintain a closure and aftercare management plan.
- 25 (a) The activities shall, subject to the conditions of this permit, be operated using the techniques and in the manner described in the documentation specified in table 25 (a), unless otherwise agreed in writing by Natural Resources Wales.
- 25 (b) If notified by Natural Resources Wales that the activities are giving rise to pollution, the operator shall submit to Natural Resources Wales for approval within the period specified, a revision of any plan or other documentation (“plan”) specified in table 25 (a) or otherwise required under this permit which identifies and minimises the risks of pollution relevant to that plan, and shall implement the approved revised plan in place of the original from the date of approval, unless otherwise agreed in writing by Natural Resources Wales.
