Waste volumes

You have made great efforts to reduce the volume of construction and demolition waste stored onsite. The C&D waste was posing a serious fire risk on site, so I am please that much of this waste has been cleared from site. Whilst I appreciate that clearing this waste should be a priority, you have allowed the volume of mixed waste to increase above permitted levels. Having this much mixed waste onsite poses a fire risk as well. During my visit we discussed the possibility of putting in place fire breaks in the waste, as per the Fire Plan you produced. You also mentioned you have brought in extra lorries to help with the clear up.

Concreting and infrastructure.

Much of the concreting has been completed at the rear of the yard. The concrete has been laid on clean compacted gravel, and looked to be about 6" thick or more. I was pleased to see the amount of work has been completed. There looked to be a couple of sections on the existing concrete, where heavy traffic has cracked and broken the concrete. We discussed that you would have these repaired as well.

We discussed the possibility of the next plasterboard bay being covered, and either bunded, lipped or inclined in such a way, that any water will not run towards the plasterboard. This should decrease the risk of pollution, and H2S, as well as improve the quality of the plasterboard.
