I have taken over from Will Powell as your Regulatory Officer. I attended your site on 21st August 2014 to conduct a Fines Audit. This audit has been conducted area-wide to make an assessment of the waste transfer station fines generated via the treatment processes at various permitted facilities. I will conduct a more thorough site handover at a later date.

I met with Jay Jones who showed me the new trommel and picking station. The following points were noted down as part of my audit:

- Fines are produced on site through the use of a trommel.
- The fines produced on site are from a mixed waste source and contain both inert and non inert material, including some wood, plastics and gypsum products. The size of the fines are fairly uniform.
- Inert waste only loads are segregated and not put through the screening process and therefore not added to the mixed waste fines.
- No fines are brought onto site from other sources.
- All fines produced on site are sent to Trecatti Landfill and described as INERT FINES, Mineral Groups 1,2,3 with a EWC code of 19 12 09
- EWC codes for other wastes leaving site were noted as 19 12 12 for mixed waste, 17 05 04 for inert waste and 17 08 02 for gypsum waste

The Duty of Care Waste Transfer Notes for the movement of the transfer station fines were inspected and copies taken. Although it was confirmed all fines are sent to Trecatti Landfill, it was found that you are using the incorrect EWC Code of 19 12 09, which describes minerals (sand and stone).

You have therefore been scored a Category 4 Breach against Directly Applicable Legislation (DAL), namely The Waste Regulations (England and Wales) 2011. Please ensure the correct EWC codes are used in future which most accurately describe the waste being imported or exported from site.

This does not affect your CCS compliance score and on this occasion, we have provided advice and guidance. However, repeated non-compliances against DAL may result in further enforcement action in future. If you have any concerns with the tax implications, please raise this with the landfill.
