A new Natural Resources Wales regulating Officer has been appointed as the site inspector for Bryn Pica (Richard Taylor replaces Gwyn Jones with immediate effect). As part of the familiarisation of the site, the materials recycling facility under EPR permit AP3199FE was viewed as part of a wider site inspection. The permitted parts have been drafted onto this CAR form to record that the permitted MRF site has been inspected.

The site was seen to be vermin and pest free. the site had no excessive noise issues experienced during the visit. Odour from permitted activities was negligible. The roofing and infrastructure was observed to be adequate for the purpose. The bulking sheds at the southern end of the site were seen to be well segregated and organised. Little wind blown litter was seen around site. The concrete hard standing at the bulking sheds was observed to be intact. No non compliances were observed during the site inspection.
