### **Introductory note**

**This introductory note does not form a part of the notice.**

The following notice gives notice of the variation and consolidation of an environmental permit.

Following the variation and consolidation application the existing permit and all changes that have been made to it throughout of its life time has now been consolidated and updated to modern Environmental Permitting Regulations standards. The changes include,

- Provision of a mattress recycling facility,
- Provision of a waste transfer station in the facilities previously used for composting sheds,
- Provision for the recycling of inert material (soil and rubble),
- Changes to the operation of the Material Recycling Facility

The variation and consolidation also include an update to the surface water management details to include a new oil interceptor and includes a new discharge point as well as an updated site location plan.. In addition, further waste types have been included in the permit to compliment the proposed facilities.

The schedules specify the changes made to the permit.
