Your Quarter 4 2017 submitted waste return has been reviewed to check compliance with Schedule 9 (Part 2) of The Environmental Permitting (England and Wales) Regulations 2016. This is because you are a notified Material Facility that is subject to the condition of complying with measurement and reporting requirements in the above regulations.

Inputs

One sample must be taken for every 125 tonnes of mixed waste material received at the materials facility from each supplier. The total weight of all the samples taken must provide an average weight of 60kg or more per sample.

You have reported taking 6 samples fewer than the minimum required (53 instead of 59) for RCTCBC supplier and 52kg fewer weight than the minimum average required (3,488kg instead of 3,540kg).

This is a breach of Schedule 9, Part 2, paragraph 4 of the Environmental

Permitting (England and Wales) Regulations 2016 and has been recorded as a category 4 non compliance.

Outputs

You have reported taking 20 samples from just 24.9 tonnes of cardboard on row 15 where 1 sample is required (one every 60 tonnes). Please check that this is not a reporting error.

Reported target material results in column M for glass and some paper & card outputs is a different figure to that reported in column AA. For example, target glass in row 8 reports 98% in column M but 99% in column AA. Please explain these differences or re-submit a corrected return to us.

Please re-submit the waste return if any errors in reporting are identified following this CAR.

Future inspections will review the inputs and output samples being taken and measured to ensure the sampling results are representative.

Any compliance criteria not highlighted in the above summary should be considered as not assessed.
